BOARD MEETING MINUTES

January 18, 2024

The regular meeting of the Board of Directors of the Omaha Public Power District ("OPPD" or "District") was held on Thursday, January 18 at 6:00 p.m. at the Omaha Douglas Civic Center, 1819 Farnam Street, 2nd Floor Legislative Chamber, Omaha, Nebraska and via WebEx audio and video conference.

Present in person at the Civic Center were Directors M. J. Cavanaugh, M. R. Core, S. E. Howard, J. M. Mollhoff, M. G. Spurgeon and E. H. Williams. C. C. Moody joined the meeting via WebEx and A. E. Bogner was not in attendance. Also present in person were L. J. Fernandez, President and Chief Executive Officer, T. F Meyerson of the Fraser Stryker law firm, General Counsel for the District, E. H. Lane, Sr. Board Operations Specialist, and other members of the OPPD Board meeting logistics support staff. Chair E. H. Williams presided and E. H. Lane recorded the minutes. Members of the executive leadership team present in person included: J. M. Bishop, S. M. Focht, T. D. McAreavey, K.S. McCormick, L. A. Olson, B. R. Underwood and T. R. Via. Joining via WebEx were K. W. Brown, C. V. Fleener and M. V. Purnell.

Open your eyes before it is too late. Not all who see have opened their eyes, nor all you look, see. To realize something too late brings no relief, only sorrow.

Not too late to cancel your net zero carbon policy.

RESOLUTION NO. 66xx

- **WHEREAS**, Winter storm Gerri (2024) exposed the inability of OPPD to supply reliable power to its customer-owners;
- WHEREAS, it is entirely foreseeable that OPPD's service area will experience bitter cold and no appreciable wind at times during the Winter;
- WHEREAS, the Center for the American Experiment ("CAE") has modeled the results on consumers if net zero carbon is achieved in the states of Minnesota and Wisconsin;
- WHEREAS, the CAE studies concluded that electricity rates would triple if Minnesota's and Wisconsin's utilities achieved net zero carbon;
- WHEREAS, CAE also concluded that Minnesota and Wisconsin would have forced 8 and 20 hour electricity blackouts in January if net zero carbon is achieved;
- **WHEREAS**, it is reasonably foreseeable that people will die if there are forced electric blackouts of any duration in January in the Midwest;
- **WHEREAS**, the safety of OPPD's customer-owners is a high priority for OPPD;
- WHEREAS, India and China currently emit multiples of the carbon dioxide tonnage that OPPD currently emits;
- WHEREAS, India and China intend to emit more carbon dioxide with the current construction and planned construction of more coal-fired power plants;
- WHEREAS, Statistics Norway has published a study establishing that man-made carbon dioxide emissions were not strong enough to have caused systemic changes in temperatures over the last 200 years; and

- **WHEREAS**, Nobel Prize winner in physics Dr. John F. Clauser and over 1600 other scientists, members of the Global Climate Intelligence Group, have declared that there is no climate emergency; and
- **WHEREAS**, there is no scientific consensus that carbon dioxide generated from human activity is changing the climate now or in the future; and
- **WHEREAS**, OPPD is a political subdivision of the State of Nebraska and subject to the laws of Nebraska, Neb. Rev. Stat. Ch. 70; and
- WHEREAS, the State of Nebraska has not adopted a law establishing that it is the public policy of Nebraska to pursue net zero carbon production or a climate action plan; and
- WHEREAS, OPPD has a dual statutory mandate to provide OPPD customer-owners with low cost and reliable electric power, Neb. Rev. Stat. §§70-1001, 70-1301 and 70-1501; and
- **WHEREAS**, solar and wind power are neither low cost or reliable.
- **NOW, THEREFORE**, **BE IT RESOLVED** by the Board of Directors of Omaha Public Power District that the following resolutions are hereby repealed and revoked: 6347, 6434, 6525, 6582, 6627 and 6628.

Analysis of Omaha World-Herald, January 16, 2024

- 1. Don't rely on the Army Corps of Engineers. A history of bad judgment and bad performance.

I'm sure MUD was within its contractual rights to do so, but this points out a major problem.

What happens when the coal-fired units at NOS are shut down, MUD cuts off the natgas supply at NOS, the wind isn't blowing and you can't buy power from Nebraska Public Power District or Berkshire-Hathaway Energy f/k/a MidAmerica Energy?

OPPD is in the reliability business. If OPPD doesn't provide reliable electricity, then people can die and millions of dollars can be lost. That's what happened in Texas.

Reliability should be <u>Job One</u> at OPPD; not saving the planet from maybe burning up in 2100.

Director Williams, December 21, 2023, "OPPD is improving the lives of people here and around the world."

OPPD has no duty to people around the world.

OPPD's only statutory duties are to provide low cost and reliable electricity to people and businesses in its service area. Neb. Rev. Stat. §§70-1001, 70-1301 and 70-1501. I would respect OPPD if it stuck to performing its statutory duties. Improving people's lives is not an OPPD duty. Low cost and reliable power does, however, improve the lives of OPPD customer-owners.

The premise of OPPD's net zero carbon policy (SD-7) is to achieve net zero by 2050 in order to prevent the planet from burning up in 2100.

I'll put aside the tiny amount of carbon dioxide that OPPD contributes to the planet's atmosphere. I'll also put aside the fact that temps have been flat.

The OPPD Board is planning on spending at least \$2b now to maybe get a result in 2100. How does that improve any OPPD's customer-owner's life now? Why pay higher rates now for an uncertain outcome in 2100?

The rate increases that will be driven by more solar and wind in the OPPD grid will not improve anyone's life now.
