Jack Lewis Safety Fund

Deadline: Fall Cycle June 15 - Sept. 1, 2025

Eligibility: Municipalities, public, 501(c)(3) tax-exempt organizations, located in Nebraska as second-class cities and villages, as well as Harrison, Mills and Pottawattamie counties in Iowa.

Description: Requested for equipment, facilities, personal protection gear, or training for first responders. Priority will be given to requests for funds that will be added to previously committed dollars raised in the local community.

T-Mobile Hometown Grants – Q2

Deadline: April 1 – June 30, 2025

Eligibility: Nonprofits and government organizations.

Description: Funding to support a community project of your choice, such as revitalizing a town hall, senior center, local little league field, or any space where friends and neighbors gather. Grants are given every quarter to up to 25 small towns and up to a \$50,000 grant for revitalizing community spaces in towns with 0,000 people or less

Firehouse Subs Public Safety Foundation Grants

Deadline: Opens Oct. 4, 2025, for Q4 2025

Eligibility: Fire departments, law enforcement, emergency medical services, municipal/state organizations and public safety organizations (nonprofits and schools are encouraged to apply for lifesaving equipment).

Description: Provide lifesaving equipment and prevention education tools to first responders and public safety organizations. Funding areas include lifesaving equipment, prevention education, scholarships and continued education, disaster relief and support for members of the military.

Nebraska Game and Parks Commission

Deadline: May 5 - Aug. 22

Eligibility: Nebraska villages, cities, public power districts, and natural resource districts (political subdivisions except for schools). Examples include playgrounds, picnic facilities, trails, ball fields, soccer fields, shelter houses, tennis courts,

multipurpose courts and modest related support facilities. In addition, acquisition of land for a new park or for land that is adjacent to an existing park and to be donated by a private individual or a corporation after federal project approval. Professional consultant services to prepare the application or provide cost estimates, also included.

Description: Funding for community outdoor recreation projects and facilities on land owned or controlled by the project sponsor.

Eligibility: Locations where Meta has data centers, including
