In order to be eligible to participate in OPPD’s Business Rebate Programs this application must be completed, submitted to and accepted by OPPD. Applicant must also complete OPPD Business Rebate Program Training and score an 80% or higher on the assessment. This is Computer Based Training (CBT) provided to applicant by OPPD as part of the application process. To maintain status any new or additional training modules are also required to be completed and assessment scored at 80% or higher.

By signing this document, the applicant agrees to the following:

1. Applicant agrees to provide OPPD customers audits and price quotes for Lighting, HVAC, ARC, ENERGY STAR Benchmarking, ENERGY STAR Certification and ENERGY STAR Building rebates at no charge. (Exceptions are possible on a case-by-case basis – if there is a need to charge for this service contact OPPD at (531)226-3536 to further discuss or email businessrebates@oppd.com explaining the situation). If an Energy Study is required for a Custom Rebate the Trade Ally may charge and those charges would fall within the Custom Rebate Program Requirements.
2. Applicant agrees to complete the online application associated with the Rebate accurately and completely.
3. Applicant agrees to abide by all Terms and Conditions of OPPD Business Rebate Programs, including all stated Qualifications for Program, Rebate Funding Requirements, General Terms and Conditions, Disclaimers, Project Requirements and Additional Criteria and Disclaimers.
