July Baseload Generation

- Nebraska City Unit 1 Capacity Factor: 75.3%
- Nebraska City Unit 2 Capacity Factor: 78.2%
- North Omaha Unit 4 Capacity Factor: 73.9%
- North Omaha Unit 5 Capacity Factor: 75.3%



July Balancing Generation

- Cass County Capacity Factor 29.3%
- Jones Street Capacity Factor 2.2%
- North Omaha Unit 1 Capacity Factor 10.5%
- North Omaha Unit 2 Capacity Factor 4.4%
- North Omaha Unit 3 Capacity Factor 28%
- Sarpy County Capacity Factor 15.2%




July Renewables

- Renewable energy contributed 24.7% of OPPD's retail energy sales.
- Wind capacity factor of 34.3%
- Capacity Factor for Community Solar 34.2%.

- Previous OPPD Net Peak Load:
 - 2011: 2,468 MW, 2021: 2,499.9 MW, 2022: 2,540 MW¹


