#### **BOARD MEETING MINUTES**

#### **December 21, 2023**

The regular meeting of the Board of Directors of the Omaha Public Power District ("OPPD" or "District") was held on Thursday, October 21, 2023 at 5:00 p.m. at the Omaha Douglas Civic Center, 1819 Farnam Street, 2<sup>nd</sup> Floor Legislative Chamber, Omaha, Nebraska and via WebEx audio and video conference.

Present in person at the Civic Center were Directors A. E. Bogner, M. J. Cavanaugh, M. R. Core, S. E. Howard, J. M. Mollhoff, C. C. Moody, M. G. Spurgeon and E. H. Williams. C. C. Also present in person were L. J. Fernandez, President and Chief Executive Officer, S. M. Bruckner and T. F. Meyerson of the Fraser Stryker law firm, General Counsel for the District, E. H. Lane, Sr. Board Operations Specialist, and other members of the OPPD Board meeting logistics support staff. Chair E. H. Williams presided and E. H. Lane recorded the minutes. E. H. Lane Sr. Board Operations Specialist OPPD is a state-sanctioned monopoly. Every person and business in its service area is required by law to purchase electricity from OPPD. There is no freedom of choice.

The OPPD Board of Directors has **exclusive** authority to set rates. Neither the Nebraska Public Service Commission nor the Nebraska Power Review Board have any legal authority to review OPPD's rates. District courts, however, do have the legal authority to review rates.

The OPPD Board has made it clear that it will pay any price and bear any burden to achieve net zero carbon by 2050.

Many **smart and savvy** people work for OPPD: L. Javier Fernandez, Lisa Olson, Jeff Bishop, Troy Va, Brad Underwood, Scott Focht etc.

**Prediction.** Staff will recommend, and the Board will approve, a series of incremental rate increases over the next 5 to 10 years in order to soften the blow of the true high cost of net zero.

OPPD rates will be 20%-25% higher within five years.

The facts establish in other jurisdictions with a high concentration of solar and wind, rates are much higher than they would be otherwise. Solar and wind are expensive and unreliable.

## Irony or Hypocrisy?

The OPPD Boad is controlled by members of the Democrat party. Traditionally, the Democrats have favored the "little guy" and been opposed to big corporations.

Qui bono from net zero?

The corporations and rich individuals who have an ownership interest in solar and wind developments. They get the federal income tax credits that reduce or eliminate their federal income tax liability; the most generous tax shelter in the history of the United States.

The amount of carbon dioxide in the atmosphere is 450 parts per million.


Percentage of man-made carbon dioxide from all industrial emissions, world-wide, is at most 5%.


$$0.045\% \times 0.05\% = 0.0025\%$$






Global energy use, 2022, EJ

Duane Murdoch 10014 54st Murray NE . Thank you for your time. We own the runway half a mile south of the proposed transition line on Mill road. My son Nathan uses this runway for his Ariel application business. From July 1st to September 30th he uses it every day he is in and out of here 30 to 50 times a day. At this point the runway runs north and south . Most of the time he takes off going north . The proposed transition line on Mill road will be in a direct line with his take off. You already have a transition line a half mile south of our runway which was installed after the runway was put in by Ron nolte many years ago . This is a registered airport with a FAA. By installing this transition line on Mill road it is a direct line with his takeoff it endangers his life. You have another proposed route which is a mile and a half north of the runway , there are less residents along that route then the Mill road route. There are seven residents in the same two mile area on Mill road at 54th Street . Matt core and Jake Farrell are telling us they are going to make some type of change to make it safe for Nathan to fly out of here. The only way I see that it could be safe is to bury it for 500 ft along Mill road north of the runway

If you just lower the line it puts it into the two residents on the intersection of 54th and Mill road. Nathan has containment for loading built here at the hanger and an office. Jake talked to him about moving the runway , you would have to move all that also plus get power and water to the site. Also they discussed moving it to a different runway , there would be a containment issue to deal with with the department of AG , fuel which you have to buy from them has a surcharge , then there is a issue of getting the herbicide there in a truck which you can't just put any truck driver in there because you are hauling herbicides . We would need to hire a driver which we don't need now. At this point the productivity is high because he lands loads and fuels in his containment and gone on 5 minutes. That time at a different airport would probably triple to 15 or 20 minutes a load time. In closing you should use the other transition proposed route. His life is in your hands , what if this was your son !!!
