BOARD MEETING MINUTES

June 20, 2024

The regular meeting of the Board of Directors of the Omaha Public Power District ("OPPD" or "District") was held on Thursday, June 20 at 5:05 p.m. at the Omaha Douglas Civic Center, 1819 Farnam Street, 2nd Floor Legislative Chamber, Omaha, Nebraska and via WebEx audio and video conference.

\$11.8 trillion in capex spending from 2023-2050 to reach net zero. Wood Mackenzie, May 2024.

Most, if not all, of that \$11.8 trillion in capex spending will qualify for federal tax credits (subsidies) for the wind and solar developers. That causes an increase in the money supply and fuels further inflation. And federal tax credits shelter regular taxable income. That increases the federal deficit and debt.

From now to 2050, if OPPD spends **\$28 billion** (2020 dollars) on wind and solar capex that will triple rates as per the studies from the Center for the American Experiment. And blackouts in January.

By 2050, the money will have been spent, rates will have tripled and it is doubtful any of you are still on the Board.

And we, OPPD customer-owners, won't find out until 2100 if the Planet was saved from burning up. We will all be dead by 2100, but the economic damage will have been done; just like in Germany today. German electric rates are \$0.43/kwh versus \$.1048/kwh for residential OPPD customers. German GDP declined 0.2% in Q4 2023.

That's the CAGW scam.

How the CAGW scam was created and how it has worked.

- 1. Manufacture a crisis. Scare people. "Never let a crisis go to waste."
- 2. Set your side up as the **savior** of the people.
- 3. Bribe the academics with research money.
- 4. Academics rig the numbers (e.g. Michael Mann's hockey stick graph and Climategate at University of East Anglia).
- 5. The media goes along for the ride because they are mostly Leftists and controversy and crisis generates clicks and views.
- 6. Get young people involved because they are impressionable, passionate and not well-educated.
- 7. Get Congress to massively subsidize all things Green with federal income tax credits. This was the critical step. Wind and solar are all about the federal income tax credits.
- 8. Move the date of destruction of the Planet to 2100; the way distant future that no adult alive today will live to see. The previous predictions all failed (e.g. No snow on Kilimanjaro by 2016).
- 9. Create a drumbeat of inevitability for the energy transition that has never been put to a vote.


My legal opinion is that you have no statutory authority to pursue a net carbon zero policy with wind and solar energy because they are not low cost and are unreliable.



You Dems have the votes here on the Board. But you are supposed to be public servants who follow the law and are concerned with the economic well-being of customer-owners and not pursuing your own private CAGW agenda. You are ignoring your statutory duty and public opinion. That's astounding.



- Good evening, Mr. Chairman and members of the Board. My name is Perre Neilan of 625 N 189th Street in Elkhorn. I'm here this evening as a spokesperson for the Welcome Home coalition.
- As you may already know, Welcome Home is a non-profit coalition that includes individuals, businesses, financial institutions, and other nonprofits. We aim to work with elected officials to bring about significant changes and improvements in public policy to make it possible for more young families, first time home buyers, and future Nebraskans to own their own homes. Our focus is on enhancing the regulatory environment in our communities including processes and delays.
- According to a recent National Association of Homebuilders study, government regulations make up 23.8% of the final price of a new single-family home nationally. Governor Pillen often cites a U-N-O study, which states that regulations account for 32.8% of the cost of a house in the Omaha metro area.
- You are no doubt aware that developers are required to pay OPPD millions of dollars for power at the beginning of a project. You may not be aware that it is often taking well over a year to get such power to a project. This not only results in hundreds of thousands, if not millions of dollars in carrying costs for the developer, who passes those costs on to the builder who passes them on to the

- eventual home buyer, it also is delaying bringing homes to the marketplace.
- Developers in Omaha have thousands of lots waiting to be powered up by OPPD. However, you are backlogged by more than a year, possibly 2 years getting power to these lots.
- We have discussed this concerning situation with OPPD staff for over a year and have only recently been promised action.
- We had numerous testifiers prepared to come discuss the status of your progress, but we are holding off to give you a couple months to implement the changes you promised.
- The National Association of Homebuilders data, updated in 2023, shows that for every \$1,000 increase in the price of a home in the Lincoln metro area, 70 households are priced out of the market, and in the Omaha-Council Bluffs metro area, that number jumps to 435 households.
- According to the greater Omaha Multiple Listing Service, the average closed price of a new construction home in the Omaha metro area for 2023 was over \$483,000. In December of last year alone, the cost was over \$512,000.
- This makes it extremely difficult for teachers, first responders and small business owners to afford a new construction home. That didn't use to be the case five to ten years ago.

- We want to work with you, your staff, and other organizations to find non tax payer subsidized solutions to make it possible for families in every neighborhood in the metro area to own a home.
- The delays of power to new neighborhoods has limited the development of new homes to maybe 2,000 houses in the Douglas and Sarpy county area in 2024. This market demands twice that number. This limited supply means higher prices. It's that simple.
- Your development team is the private sector that wants to bring you new customers. We appreciate your willingness to make meaningful change to get us out of this housing crisis. Thank you, Mr. Chairman.
