
StormReady® Community Partner

SOUTHWEST POWER POOL (SPP) REGIONAL TRANSMISSION ORGANIZATION (RTO) WEST EXPANSION

- Approval Granted: SPP received Federal Energy Regulatory Commission (FERC) approval in March to expand its RTO into the Western Interconnection.
- **Historic Milestone:** SPP will be the first RTO to operate in both the Eastern and Western Interconnections.
- **New Members:** Seven Western utilities will join the RTO in April 2026.
- **Strategic Growth:** The expansion supports SPP's *Aspire 2026* plan and brings reliability, market, and cost benefits.
