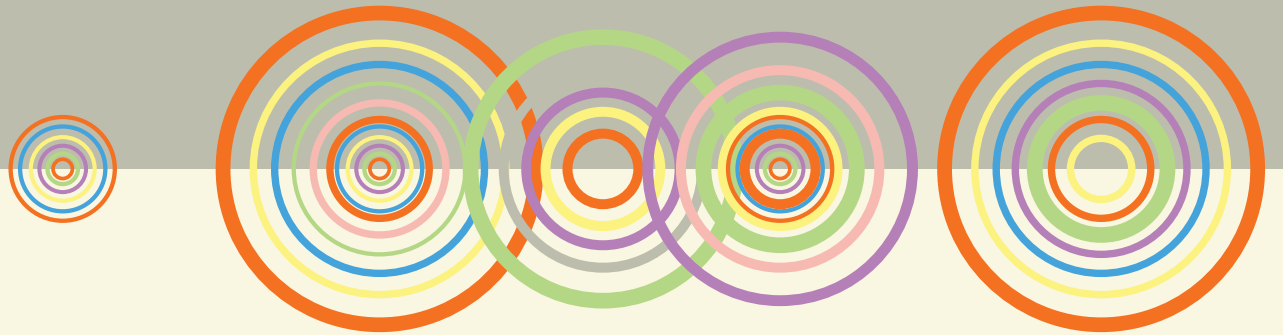

# **JANUARY 2026 BASELOAD GENERATION**

Nebraska City Unit 1 – Capacity Factor: 67%

Nebraska City Unit 2 – Capacity Factor: 75%

North Omaha Unit 4 – Capacity Factor: 56%

North Omaha Unit 5 – Capacity Factor: 33%

# JANUARY 2026 BALANCING GENERATION

Cass County – Capacity Factor: <1%

Jones Street – Capacity Factor: 2%

# ADDITIONAL UPDATE

In alignment with Board Resolution 6744 regarding North Omaha Station operations, management will initiate an SPP transmission tariff study within 30 days of receiving all required and approved SPP interconnection agreements.

The SPP transmission tariff study was initiated on January 22, 2026. SPP has up to a year to finish the study and management will provide updates as the process progresses.



# 5 YEARS SINCE WINTER STORM URI

- **Advanced Metering Infrastructure:** Technology platform deployed (ex. new outage map) and AMI meters being deployed over the coming years
- **Dual Fuel:** New generation has dual capabilities and was designed to operate in extreme cold and plan to add dual fuel at existing balancing sites
- **Weather Hardening:** Significant investments made to our existing generation fleet
- **Enhanced Emergency Procedures:** Includes training and contract language to enhance our preparation, management and response to grid emergency events
- **Southwest Power Pool:** As a SPP member, we're engaged in their improvement efforts to better seasonally assess and manage potential grid emergency events

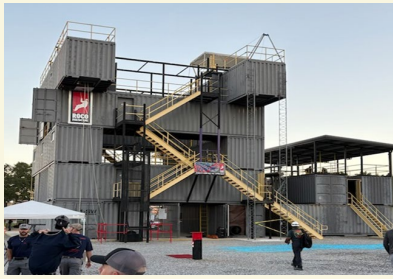
