

## REC Subscribe Pro Terms and Conditions

By agreeing to purchase Renewable Energy Certificates (RECs) under this Program, Participants agree to the qualifications, terms, and conditions of the Program, as they may be changed from time to time by the Omaha Public Power District (OPPD).

### Program Details

This REC Program allows qualified OPPD customers to voluntarily support renewable energy and offset their carbon emissions by purchasing RECs supplied by OPPD. This Program allows qualified OPPD customers to purchase RECs which will be retired by OPPD on their behalf. Program Participants have the option to match their energy usage with RECs in increments of 10%, ranging from 10% to 100%.

### Program Qualifications

Participants must be customers with OPPD account(s) in good standing and taking service under a demand rate (Rate Schedule Numbers 231, 231M, 232, 245, 250, 261M or 357).

### Program Terms and Conditions

1. Participants are billed monthly based on their energy usage, the chosen energy usage match percentage, and the price of the RECs as determined by OPPD. See [OPPD.com](http://OPPD.com) for current pricing.
2. RECs purchased by Participants will be retired annually by OPPD on the Participants' behalf.
3. Participants will receive documentation on the number of RECs retired by OPPD on their behalf.
4. These RECs will be bundled and come from a Center for Resource Solutions Listed (CRS Listed) facility. The RECs will be generated within the 21-month standard time period per the Environmental Protection Agency's (EPA) Green Power Partnership Program.
5. Participants cannot transfer the underlying environmental attributes reflected in the purchased RECs to any other party.
6. OPPD intends to review the price for RECs on at least an annual basis. Participants will be notified in advance of any price changes.
7. Program enrollment is available on a first-come, first-served basis.
8. Participation in this REC Program does not constitute or represent ownership of any renewable resources.
9. Participation in this Program will continue indefinitely unless one of the following occur:
  - a. Participant moves or stops electric service
  - b. Participant or OPPD terminates participation in the Program in writing.
10. Termination of participation in this Program will be effective with the Participant's next billing period.
11. OPPD reserves the right to cancel this Program at any time for any reason such as but not limited to the following:
  - a. Introduction of regulatory or legislative policies/requirements
  - b. Administrative or other error
  - c. Low REC volume or production
