July Baseload Generation

- Nebraska City Unit 1 – Capacity Factor: 82.1%
- Nebraska City Unit 2 – Capacity Factor: 76.7%
- North Omaha Unit 4 – Capacity Factor: 79.6%
- North Omaha Unit 5 – Capacity Factor: 64%

July Peaking Generation

- Cass County – Capacity Factor 19.1%
- Jones Street – Capacity Factor 0.6%
- North Omaha Unit 1 – Capacity Factor 0.3%
- North Omaha Unit 2 – Capacity Factor 0%
- North Omaha Unit 3 – Capacity Factor 8.5%
- Sarpy County – Capacity Factor 5.6%

July Renewables

- Renewable energy contributed 27% of OPPD's retail energy sales.
- Wind capacity factor of 36.6%

EV Rebate Program*

Residential Rebates

Similar to previous years, rebates remain available for residential customers that purchase a new all-electric vehicle:

- Car/charger combo rebates available= 93
- Charger only rebates available= 113

Business Fleet Rebates

NEW rebates are available for business customers who replace a current fleet vehicle with a new all-electric vehicle:

- Fleet Car/charger combo rebates available= 36
- Charger only rebates available= 20
